**2012 Annual Spring Skating Show – Freestyle Groups & Soloist**  
**Registration Form**  
**Sunday, April 1, 2012 4-5:50pm - Deadline to Register: January 13, 2012**

The freestyle groups are open to all MVSC skaters who are no longer working on the basic skills badge levels (Pre-Preliminary and up) but do not yet qualify for a solo. If your skater is enrolled in Basic Skills classes and also skates on a Freestyle session they will be in a show group with the Basic Skills group skaters. If your Freestyle skater is below the level of the freestyle group skaters (still working on badge levels) they will be placed with the appropriate basic skills group instead. Please contact Nikki for further clarification of this show policy.

All soloists and freestyle group skaters must be members of MVSC. Soloists must have passed the Preliminary Freestyle and Preliminary Moves tests by the deadline of January 13, 2012. Soloists are required to take part in a Freestyle group as well. Soloists who have passed the Juvenile Freestyle test and higher may have a program up to, but not exceeding, 2 ½ minutes. Skaters who are below the Juvenile Freestyle level may have a program up to, but not exceeding, 2 minutes. All soloist music and costumes must be approved by Nikki before they are used.

**Show Theme:** “America the Beautiful”

**Costume Measuring for the Advanced Groups:**

- **You are responsible** for providing the dress and skating tights size of your skater. (Sizing chart provided)
- If you are unsure of your size please contact Tina Kennedy at 978-729-7290. It is more important to size up instead of down. Alterations will not be provided. You are responsible for the correct fit of the costume! Please allow for growth between time of registration and April.

**Rehearsals for the Advanced Group:**

- Anyone performing as a soloist must take part in a Freestyle Group number.
- Each Advanced Freestyle group will have 3 rehearsals plus one dress rehearsal with the entire cast.
- Attendance at all rehearsals is mandatory. You must speak to Nikki in order to have an absence excused.
- The **Freestyle Groups** will be **rehearsing on: Sunday, March 11<sup>th</sup>, 18<sup>th</sup> & 25<sup>th</sup> from 4-4:50pm. Please note that on 3/11 there will be an additional hour of off-ice practice from 3-3:50pm (Graf conference room).**

**Dress Rehearsal for All Soloists and Freestyle Groups: Thursday, March 29<sup>th</sup> from 6-7:50pm.**

**Show Date: Sunday, April 1<sup>st</sup> 4-5:50pm:** All soloists and freestyle group skaters will need to arrive at the rink by 3:00pm. Soloists and Freestyle Group skaters will have a warm-up prior to the start of the show. That time will be announced closer to the show date.

**Freestyle Group Fee:** The show fee is **non refundable** as costumes and ice time are prepaid. Cost: \$120.00 per skater. The Advanced Freestyle Group show cost includes:

- Skating outfit suitable for use after the show.
- All rehearsal ice.
- All professional coaching time for the group rehearsals and dress rehearsal.

**Soloist Fee:** There is a \$30 fee for each soloist in addition to the Freestyle Group fee. This fee will help defray the cost of our ice time for the dress rehearsal and show.

In consideration of permission to use, today and on all future dates, the property, facilities and services (Facilities) of Graf Skating Rink in Newburyport, MA, I, the undersigned (Parent/Skater), hereby expressly agree:

- 1.) That skating is a participation sport and I am fully aware of the risks and hazards involved in or arising from my use or presence upon the facilities. I hereby assume any and all risks involved in or arising from my use of our presence upon the facilities, including, without limitation, the risks of bodily injury resulting from collision between myself and another person or a stationary object or the negligent or deliberate act of another person.
- 2.) To release NSRM and/or MVSC and all of its successors, assigns, affiliates, officers, directors, employees and agents from, and agree not to sue any or all of them on account of or in connection with any claims; causes of action, injuries, damages, costs or expenses arising out of Skater's use of or presence upon the Facilities, including, but not limited to, those based on bodily injury, whether or not caused by the negligence or other fault of NSRM and/or MVSC.
- 3.) This release shall be binding upon my heirs, administrators, executors, assigns and legal representative.
- 4.) To waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
- 5.) If I ignore this agreement and file suite, I will be held responsible for all attorney fees and court costs incurred by NSRM and/or MVSC.
- 6.) I have read and understand this agreement. I understand that by signing this agreement I surrender valuable rights, including, but not limited to, my right to sue. I do so waive voluntarily.
